North Plainfield Bulk Waste Program will be accept applications for Bulk Waste permits after March 15 for April, May 15 for June and August 15 for September pickup. North Plainfield Metal Waste Program will be accept applications for Metal Waste permits after August 15 for September pickup. please remember:

- Appointments are reserved on a first come first served basis and Bulk appointments will only be made receipt payment of fee.
- An application must be submitted with a non-refundable permit fee of \$10.00 per Bulk item up to \$50.00 for a maximum of five (5) items at the time of registration. Completed applications can be dropped off to the Department of Public Works Monday – Friday between 8am – 4pm.
- Applications will be available at *northplainfieldnj.gov* or can be picked up at the DPW office at Borough Hall.
- **Metal is only collected in September and is free.** Metal and bulk items must be kept seperated.

### **COLLECTION GUIDELINES**

Collection of materials will be made by Section according to the Borough of North Plainfield Collection Map. We are limited to the amount of stops per collection; therefore, it is on a first come, first served basis. Collection of materials will be random within each section; therefore, material must be placed at curb by 7AM on the assigned collection date. It is important that all materials be out by 7AM because collection moves quickly and your Bulk/Metal waste will not be picked up if you do not have materials curbside prior. Please note that Bulk Waste pickup does not include metal. This is a separate pickup. Any unauthorized materials left at the curb in excess of the number of items scheduled and/or do not qualify for Bulk/Metal waste pickup, must be removed by 6PM of the day collection is made. Failure to comply will be subject to the provisions of Section 14-8.5 of the Borough Code.
